No.10/4/2006-FX(PEN): Under the existing pension disbursement system all pensioners are required to appear before the concerned Treasury Officer every six months for renewal of their data and updation of the digital photograph. This requirement is relaxed in respect of the ex-MLAs and accordingly, the Governor of Manipur is pleased to insert the following sub-paras under sub-para (XII) of para 3 of this Department's order of even number dated 17.12.2007 as follows:

- (XII)(A) Ex-MLAs are exempted from appearing for life photography in the Treasury Offices, if they so desire, on the condition that the Assembly Secretariat shall be responsible for timely transmission of information pertaining to the demise of ex-MLAs based on which the pension data-base shall be updated in the Treasury Offices. The Assembly Secretariat shall appoint a Nodal Officer for this purpose.
- (XII)(B) The Director, Treasuries & Accounts, Manipur shall take appropriate steps to depute a responsible Official of Treasury to visit the residence of such ex-MLAs who are exempted from appearing before the Treasury Officer, once every six months to capture the photographs.
- (XII)(C). The exemption shall not be extended to family members of the ex-MLAs in the case of family pension.
